

The Delhi Pollution Control Committee (DPCC) invites proposals from Authorized E-Waste Recyclers who fulfill the eligibility criteria for lifting, transport and recycling/disposal of E-Waste collected from the units/premises sealed by MCD during the joint enforcement drive in Mustafabad, Delhi on 24.06.2025. Interested Recyclers can furnish their details within 07 days from the date of this notification.

Interested recyclers must be duly registered with CPCB on EPR Portal under the E-Waste (Management) Rules, 2022, having valid Consent and Authorisation from concerned State Pollution Control Boards/Committees (SPCBs/PCCs) and also must comply with all applicable environmental laws and regulations. The objective is to promote legal, scientific, and safe handling, processing, and recycling of e-waste in Delhi.

**Eligibility Criteria:**

1. Valid registration with CPCB under E-Waste (Management) Rules, 2022.
2. Valid Consent to Operate (CTO) and Authorization under Hazardous and Other Wastes Rules, 2016, as amended to date, from concerned State Pollution Control Boards/Committees (SPCBs/PCCs).
3. Compliance history – The unit should not be under any litigation or non-compliance proceedings with respect to environmental violations.
4. Adequate infrastructure for collection, transportation, dismantling, and recycling in accordance with CPCB guidelines.
5. Track record of e-waste handling (minimum quantity handled in the last 03 years, if applicable).

**Documents Required:**

1. Copy of valid CPCB Registration as E-Waste Recycler.
2. Copy of valid CTO & HWM Authorization OR Consolidated Consent and Authorization (CCA) from concerned State Pollution Control Boards/Committees (SPCBs/PCCs).
3. PAN Card and GST registration.
4. Details of installed capacity and quantity of e-waste handled/recycled during the last 03 financial years.

**Submission of Proposal:**

Eligible recyclers are requested to **submit their proposals along with required documents** by email/ at [wmc2dpcc2025@gmail.com](mailto:wmc2dpcc2025@gmail.com) or physically to the office of the undersigned within 07 days from the date of this notification on DPCC Website. The subject of the email/envelope should clearly mention **“lifting, transport and recycling/disposal of E-Waste collected from the units/premises sealed by MCD during the joint enforcement drive in Mustafabad, Delhi on 24.06.2025.”**

Shortlisted recyclers may be called for further technical discussions or presentations.
